1- SOURCE OF FUNDS

The Central American Bank for Economic Integration (CABEI) as part of the services provided to CABEI partners and beneficiary countries, is granting partial funding jointly with the Kuwait Fund for Arab Economic Development (KFAED) for the implementation of the project «Supervision for Construction and Equipment of the Departmental Hospital of Chinandega» Republic of Nicaragua, under the Loan Agreements N° 2124 and N° 899, signed by the Government of Nicaragua and CABEI and the Republic of Nicaragua and KFAED.
