LOT 3.1 CONSTRUCTION OF CIVIL WORKS FOR
POWERHOUSE, TAILRACE AND SWITCHYARD**

- 1 - Pakistan Water and Power Development Authority (WAPDA) (The Client) through General Manager (Hydro) Planning WAPDA intends to pre-qualify contractors for Lot 3.1 Construction of Civil works of Powerhouse, Tailrace and Switchyard (hereinafter called the Works).
- 2 - The contract reference number is Lot: 3.1 Golen Gol Hydro power project and it is anticipated that the work will commence in July 2008 and will be completed within 42 months. The financing is from Kuwait Development Fund.
- 3 - A brief description of the contract is as follows:
Golen Gol Hydropower Project is a run off the river project designed for the generation of 106 MW consisting of three units in one phase with average energy output of 436 Gwh.
The project area lies in the Mastuj valley of Chitral District of Northwest Frontier Province (NWFP) of Pakistan with approximate height of 1830 to 2440 m. surrounded with mountains ranging from 4875 to 5800 m.
The Project Site is located on the left bank of Golen Gol river and --- is about 2 km upstream of Golen Village and powerhouse site on the left bank of Mastuj river near its confluence with Golen Gol River along Chitral Bunni Road.
The major components of the works are listed below:
i) Powerhouse Civil works ii) Tailrace Civil works iii) Switchyard Civil Work
- 4 - An applicant may form Joint venture with other firm / contractors for the purpose of prequalification for the works. Prequalification application submitted by a Joint Venture must be accompanied by documents in support of the formation of Joint Venture. Such document must set forth the extent of responsibility and participation of each member of joint venture, its duration and the person (s) authorized to represent and delegate it, and include other relevant Information. Each prequalified Joint Venturer will be required to submit along with its tender the duly executed agreement formalizing the joint Venture. The Members of the Joint Venture shall be Jointly and severally liable.
- 5 - Prequalified Firms/Joint Ventures will subsequently be invited to participate in tendering.
- 6 - Applicants should ensure that all submitted information is correct. Prequalification of any contractor may be withdrawn at any time up to award of contract, if significant errors are found in the information submitted by the contractor.
- 7 - Prequalification is open to Pakistan and foreign firms Licensed by the Pakistan Engineering Council (PEC) In the category relevant to the value of the work. Under the by-laws of PEC, Foreign firms are required to form joint ventures with the Pakistani firm/firms. The share of Pakistani firm/firms in the joint venture shall not be less than thirty percent (30%).
- 8 - Contractors interested in receiving prequalification documents can obtain the same upon written application and upon payment of the printing charges (non – refundable) of Rs - 5,000 (Rupees Five Thousand only) or US \$ 80 (Eighty) from the office of the General Manager (Hydro) Planning WAPDA, Sunny View Estate, Kashmir Road, Lahore, Pakistan.
Contractors interested to receive the documents through post outside Pakistan will have to pay additional amount of Rs 500/- (Rupees five hundred only) as mailing charges. The bank draft should be prepared in the name of General Manager (Hydro) Planning WAPDA, Sunny View Estate, Kashmir Road, Lahore, Pakistan. The prequalification documents shall be completed in English language and returned in sealed envelope, so as to reach the office of the General Manager (Hydro) Planning WAPDA, Sunny View Estate, Kashmir Road, Lahore, Pakistan at or before 1100 Hrs on 11/3/2008.
- 9 - The decision of the client as to whether or not the applicant is eligible to tender shall be final and binding.
